The petitioner Sri Fakruzzaman Laskar has authorized Sri Mahmudul Hussain , Advocate to represent him in the hearing today due to his illness. The SPIO of the office of Child Development Project Office, Hailakandi is absent without any information. The First Appellate Authority is also absent.

No written statement has been received by this Commission from the SPIO of the office of the CDPO, Nalbari for his/her failure to furnish the information to the petitioner within the stipulated period of 30 days.

This Commission, therefore, directs the CDPO, Hailakandi ICDS project to furnish the information sought for by the petitioner within 15 days from the date of receipt of this order and also to submit a written explanation to this Commission within 15 days from the date of receipt of this order, as to why penalty shall not be imposed on him under Section 20 (1) of the RTI Act, 2005 for his failure to furnish the information to the appellant within 30 days.

Further, this Commission hereby orders that the First Appellate Authority /CDPO, Hailakandi shall consider and dispose the first appeal petition dated 18-5-2017 with a speaking order within 21 days from the date of receipt of this order.
