O R D E R

1. The petitioner Sri Bhaskarjyoti Das is absent without any information. The public authority is represented by Smti Ruby Sharma, ACS, Joint Secretary and SPIO of Transport Department, Govt. of Assam.
2. The second appeal petition dated 2-1-2016 is taken up for further consideration in pursuance of this Commission's earlier order dated 3-7-2017.
3. The Joint Secretary and SPIO has made a written submission with enclosures which is entered into the case records. In her written statement it is mentioned that out of a total number of 24 Nos. of MVIs the sought for information in respect of 20 MVIs have since been furnished to the petitioner. Out of the remaining 4 MVIs, one Sri Prasanta Gogoi has retired and one Sri Ajit Langthasa has expired. Hence informations in respect of these two MVIs could not be furnished. The remaining two MVIs namely, Sri Tarun Ch. Phukan and Sri Rajendra Kr. Dutta have requested to give them further time for tracing out their documents, which they informed have been misplaced due to long tenure of service.
4. In view of the above, this Commission directs the SPIO of Transport Department to obtain the relevant informations from MVIs Sri Tarun Ch. Phukan and Sri Rajendra Kr. Dutta and furnish the same to the petitioner within 45 days from the date of this order, which was pronounced in her presence. If for any reason, she is unable to furnish the information, within 45 days time, then she will inform the RTI applicant accordingly stating the reasons for her inability to furnish the information.
5. With the above order, the second appeal petition dated 2-1-2016 is disposed of.
