O R D E R 0 4-10-2017

- The appellant/petitioner Sri Gobinda Rajbangshi is present. The public authority is reporesented by Sri Amalendu Ghosh, SPIO –cum- Chief Engineer ((A&T), ASTC, accompanied by Sri Nirmal Kakati, Law and Claims Officer of the same office and Mrs Mayuri Kalita, Law and Claims Officer both from ASTC.
- 2. The second appeal petition dated 12-7-2017 is taken up for hearing in presence of both the parties. The SPIO of ASTC submitted a written statement dated 4-10-2017 which is entered into the case records.
- 3. From perusal of the case records it is seen that the petitioner filed an RTI petition dated 24-2-2017 before the SPIO of ASTC, seeking various informations against six points concerning ASTC. The ASPIO of ASTC had furnished some informations to the petitioner by a forwarding letter dated 8-5-2017. The petitioner's plea before this Commission is that the informations received by him so fare are not complete.
- 4. After going through the RTI petition and the W/S submitted today by the SPIO of ASTC, and the informations already furnished, the SPIO of ASTC is directed to furnish to the petitioner photocopies of the sanction letters of budgetary supports by the State Govt. to ASTC within the last three years i.e., 2014-2015, 2015-2016 and 2016-2017, which are public documents, within 20 days from the date of this order, which was pronounced in presence of both the parties.
- 5. The remaining informations sought for by the petitioner appears to have already been furnished, as is seen from the enclosures to the SPIO's letter dated 8-5-2017.
- 6. With the above order the second appeal petition dated 12-7-2017 is disposed of.
