O R D E R

1. In pursuance of this Commission's earlier order dated 4-7-2017 the matter is taken up for review of the actions taken by both the parties.
2. It is seen from the case records that the petitioner Sri Dulal Bora, vide his letter dated 24-7-2017, submitted to this Commission a bunch of papers containing – (a) copies of informations- 8 pages under Right to Information and (b) RTI petitions- 8 pages in respect of second appeal case Nos- SIC/K:P(M) 62/2017, SIC/ KP(M)97/2017, SIC/KP(M).96/2017, SIC/KP(M) 94/2017, SIC/KP(M) 95/2017, SIC/KP(M)61/2017, and SIC/KP(M) 98/2017 and no list of important informations sought for by him as was directed by this Commission in its order dated 4-7-2017. On receipt of the above papers the Registry of this Commission sent them to the SPIO of Deori Autonomous Council vide forwarding letter dated 18th August, 2017.
3. The SPIO, Deori Autonomous Council has submitted a prayer dated 31-8-2017 stating that they received the communication dated 18-8-2017 from this Commission only on 30-8-2017 and due to this late receipt they have not been able to furnish any information to the petitioner so far. The SPIO has prayed for 6 (six) weeks time to furnish the documents prayed for by the petitioner Sri Dulal Bora.
4. The time prayed for is granted for furnishing the admissible and available informations to the petitioner as already indicated in paragraph No. 6 (six) of this Commission's earlier order dated 4-7-2017.

5. Fix **23-10-2017, 12, 30 P.M** for review of actions taken and ***issue notice to both the parties for their attendance on the next date of hearing.***
