Shri Akram Ali, Senior Assistant and Shri Akhil Medhi, LDA as the representatives of the Circle Officer, Matia Revenue Circle are present. They submitted a Written Statement dated 09.08.2017 from the Assistant Settlement Officer, Matia Revenue Circle, Goalpara.

A Written Statement dated 05.08.2017 has been received from the Additional Deputy Commissioner/SPIO, office of the DC, Goalpara.

The Appellant, Shri Saman Ali Sk is present.

Heard the Appellant. He submitted that he had not received the information he had sought for. However, he had received a letter dated 24.02.2017 with detailed estimate asking him to deposit an amount of Rs. 16/- (Rupees sixteen) for supply of eight documents. He stated that he did not deposit the said amount as he had received the said letter after he submitted his Second Appeal.

Perused the Written Statements and heard the deputies of the ASO, Matia Revenue Circle, Goalpara including enclosures containing the information. It has been submitted that the information was ready to be furnished with the Appellant with the said amount, if the cost of photocopying is deposited.

In view of the facts brought out above, the Commission hereby orders that the Appellant shall deposit the said cost of photocopying within 7 days of receipt of this order and within 10 days of receiving the said payment, the SPIO shall furnish the information/certified documents to the Appellant.
