**O R D E R**  
16.08.2017

Shri Satyesh Nath, SPIO and APO (T), Darrang Zilla Parishad is present. He has submitted a Written Statement dated 14.08.2017 along with the Written Statement from the First Appellate Authority/Chief Executive Officer, Darrang Zilla Parishad.

The Appellant, Md. Amir Hussain is present.

Heard the SPIO and perused the Written Statements. It is seen that action was not taken in time to furnish the information and that it was only after the FAA issued an order that the Appellant was requested to inspect the records in view of the same being voluminous. The request was made through a letter dated 20.06.2017. However, the Appellant did not respond.

Heard the Appellant. He submitted that he had not received the information and that he could not respond to the request for inspection.

Considering the scope of the Application for information and the submission of the Public Authority regarding the volume of the records to be photocopied, the Commission hereby orders that the Appellant shall respond to the request of the SPIO and inspect the records, take notes etc. which shall be certified by the SPIO or the concerned authority and specify the essential records whose photocopies would be required. The SPIO shall furnish upto 50 photocopies, free of cost, and the cost for the rest shall be borne by the Appellant. The date of inspection shall be fixed by the SPIO in consultation with the Appellant and shall be completed within 3 working days.

The Second Appeal is hereby disposed of.
