Dr. Hemanta Kr. Chaliha present as deputed by the Appellant.

The SPIO absent. However, the Principal & Secretary, Governing Body of Lakhimpur Kendriya Mahavidyalaya, Lakhimpur has submitted a Written Statement dated 10.08.2017 by e-mail.

Perused the Written Statement. It has been submitted that in compliance with the Commission's order dated 30.01.2017 information had been furnished to the Appellant through a letter dated 16.03.2017. A copy of the said letter has been enclosed with the Written Statement. However, no copies of the documents furnished have been enclosed.

Perused the case record. It is seen that the Second Appeal had been disposed of with an order dated 30.01.2017 requiring the SPIO to furnish the information sought for through his RTI Application dated 25.04.2014 relating to the academic qualification and the evaluation of candidates for the post of Principal of the College. The Complaint dated 06.04.2017 was thereafter received from the Appellant stating that the information/documents had not been provided fully and the number of documents provided was not mentioned, or the page number also were not certified.

Heard the Appellant's depute. He reiterated the main points of the Complaint.

After a careful consideration of the submissions by the Appellant and the Principal of the college, the Commission concludes that there were indeed shortcomings in the way information has been furnished to the Appellant and no certificates have been furnished in connection with coordination of seminar by the current Principal of the College. The Commission therefore orders that the SPIO/Principal, Lakhimpur Kendriya Mahavidyalaya shall furnish the remaining documents and take action as indicated below –

- (i) The certificates in connection with coordination of national seminars on 27.12.2010 and 6th and 7th January, 2012 by the Principal Dr. Golap Sarmah Baruah at Murkongselek College listed at serial number 12 in the list of conferences/seminars/workshops etc. participated, and

- (ii) The certified copy of the order issued by the Director of Higher Education, Assam promoting the said Principal, Dr. Golap Sarmah Baruah as associate professor. The SPIO/Principal of the said college shall furnish the above mentioned certified documents to the Appellant within 10 days of receipt of this order.

The Complaint of non-compliance is hereby disposed of.
