**O R D E R**  
**25-10-2017**

1. The appellant/petitioner Sri Jyoti Prakash Ghosh is present. The public authority is represented by the Circle Officer of Dispur Revenue Circle.
2. The second appeal petition dated 12-5-2016 is taken up for further consideration in pursuance of this Commission's earlier orders dated 22-8-2017 and 2-10-2017.
3. The Circle Officer submitted a written statement dated 23-10-2017 stating that despite his repeated efforts including detailed discussion with the concerned employees at the relevant point of time, the sought for records could not be traced out.
4. As regards paragraph 5 (i) of this Commission's order dated 22-8-2017 the Circle Officer prayed for additional time up to 5 working days to verify the authenticity of the Jamabandi correction dated 30-10-2010 with reference to relevant records maintained in the Revenue Kanungo branch of the office of Deputy Commissioner, Kamrup (Metro) and inform the petitioner about the correct position in this regard. The Circle Officer further submitted orally that it is possible that office mutation proceeding might not at all had taken place and for that reason no office records may be available.
5. Time as prayed for is granted and fix **10-11-2017, 1.30 P.M** for review of action taken by the Circle Officer, Dispur Revenue Circle.
