**O R D E R**

1. The appellant/ petitioner Sri Dibakar Choudhury is present. The public authority is represented by the SPIO and Additional Deputy Commissioner, Kamrup (Metro). The second appeal petition dated 15-9-2017 is taken up for hearing in presence of both the parties.
2. The second appeal petition dated 15-9-2017 is with reference to two separate RTI petitions both dated 18-3-2017. By his first RTI petition the petitioner wanted certified copy of Chitha of a plot of land , particulars of which are mentioned in the RTI petition. The SPIO and Addl. Deputy Commissioner, Kamrup (Metro) furnished the sought for information to the petitioner in presence of this Commission today. The petitioner received the Chitha copies to his satisfaction by giving an acknowledgement receipt to the SPIO.
3. The SPIO and Addl. Deputy Commissioner, Kamrup (Metro) prayed for 30 days time to furnish point-wise replies to the informations sought for by the petitioner, except against point Nos. (i) and (ii) of other details in page No. 2 of the RTI petition.
4. With the above order the second appeal petition dated 15-9-2017 is disposed of.
