O R D E R

- 1. The appellant/petitioner Sri B.C.Thakuria is present. The public authority to be represented by the SPIO and Associate Planner of Guwahati Municipal Corporation Sri Santanu Das is absent without any information.
- 2. On the last date of hearing i.e., on 8-6-2017 the Associate Planner prayed for 30 days' time to furnish the required informations to the petitioner. Time as prayed for by him was granted with the direction that he will furnish the documents mentioned in this Commission's order dated 8-6-2017 on or before 10th July, 2017. The petitioner submitted that he has not received those documents till date. In this connection the non-compliance complaint petitions dated 12-7-2017 and 4-9-2017 were received by this Commission and a compliance report was called for from the Associate Town Planner vide this Commission's letter dated 10-5-2017. No response has been received from the Associate Town Planner till date. In his absence in the hearing today at the time of todays' hearing it could not ascertained whether he took any steps to comply with this Commission's order dated 8-6-2017. Therefore, the position as of today is that:-
 - (i) The Associate Town Planner and SPIO of GMC has failed to furnish the required information to the petitioner within the stipulated time, and
 - (ii) He has failed to comply with this Commission's order dated 8-6-2017.
- 3. He is, therefore, directed to show cause on or before 25th October, 2017 as to why penal actions under Section 20 of the RTI Act., 2005 shall not be taken against him.
- 4. Fix **15-11-2017**, **1.30 P.M** for personal hearing of the delinquent official i.e.,the Associate Town Planner of Guwahati Municipal Corporation, in person..
