O R D E R

1. The appellant/petitioner Sri Rakesh Hazarika is present. The public authority is represented by Mrs. Kabita Rani Das, SPIO and Addl. Registrar of Cooperative Societies, Assam, Khanapara, Guwahati-22 accompanied by Md. Razzaqul Hussain, ASPIO and Sub-Registrar of Cooperative Societies, of the same office.
2. The second appeal petition dated 28-8-2017 is taken up for hearing in presence of both the parties.
3. The Addl. Registrar of Cooperative Societies and SPIO submitted a written statement dated 9th October, 2017 stating that the informations sought for by the petitioner vide his RTI petition dated 10-3-2017 have been furnished to him. Copies of the informations was also enclosed with the written statement dated 9-10-2017. The petitioner Sri Hazarika acknowledged that he received the informations yesterday. However, he was not satisfied on two points:-
 - (i) Copy of Treasury Challan or vouchers with Head of Account by which the proceeds of the auction , pursuant to RCS's order No. CR.7/05/3 dated 20th June, 2014 was deposited to the State Exchequer,
 - (ii) The final disposal price of the items listed at Sl. No. 3.4.6,8 and 9 in auction notice No. CR.7/05/9 dated 12th December, 2014 were lower than the prices mentioned against those items in the auction notice. The petitioner wanted copies of orders or any other record mentioning the reasons for disposal of the items at lower rates.
4. The SPIO and Addl. RCS is directed to furnish the above two informations to the petitioner within 15 days from the date of receipt of this order, which was pronounced in presence of both the parties.

5. With the above order the second appeal petition dated 28-8-2017 is disposed of.
