- The appellant/petitioner Sri Rajib Deka is present. The public authority is represented by Sri Utpal Ch. Bhattacharya, I/C Branch Manager, Assam Seeds Corporation Ltd. (ASCL), Dhubri branch.
- 2. The second appeal petition dated 19-8-2017 is taken up for hearing in presence of both the parties.
- 3. The I/C Branch Manager, ASCL , Dhubri submitted a written prayer dated 11-9-2017 seeking two months' time to furnish the sought for information to the petitioner on the ground that he is busy with other pressing official works like distribution of seeds etc. The petitioner submitted that in the meantime he has received some information from the I/C Branch Manager of ASCL, Dhubri. - 4. This Commission directs the Branch Manager, ASCL, Dhubri to furnish the above mentioned informations to the petitioner within 30 days from the date of receipt of this order, which was pronounced in presence of both the parties.
- 5. With the above order the second appeal petition dated 19-8-2017 is disposed of.
