O R D E R
18-12-2017

1. The appellant/petitioner Sri Dulal Bora is absent. The public authority is represented by Sri Prasanta Borkakakati, SPIO and Deputy Secretary to the Govt. of Assam, Personnel (A) Department accompanied by Sri Ankur Sarma, Junior Assistant of the Department.
2. The second appeal petition dated 24-7-2017 is taken up for consideration ex-parte in the absence of the petitioner.
3. The Deputy Secretary and SPIO submitted a written statement dated 18th December, 2017 which is entered into the case records. In his W/S the SPIO has mentioned that the petitioner submitted a large number of RTI applications at the same time making it difficult for the department to maintain proper records and furnish the sought for informations within the stipulated time.
4. In the instant case, it is seen that the petitioner filed a complaint petition dated 6-11-2015 before the Chief Secretary, and followed it up by an RTI petition dated 9-8-2016 submitted before the SPIO of Chief Secretary's Office, seeking the following informations:-
 - (i) **File No. from which, inquiry, if any, was ordered in pursuance of his earlier complaint petition dated 6-11-2015 before the Chief Secretary to the Govt. of Assam, along with the name of the Inquiry Officer and his present designation,**
 - (ii) **Names and addresses of the persons against whom allegations were made in his complaint petition dated 6-11-2015, and**
 - (iii) **Copy of the report of inquiry, if any such report was submitted to the concerned higher authorities.**
5. Not getting any response to his RTI petition dated 9-8-2016 the appellant filed his first appeal petition dated 16-5-2017 followed by the present second appeal petition dated 24-7-2017 before this Commission.

6. In his written statement the SPIO has submitted that the RTI petition dated 9-8-2016 was received from the SPIO of Chief Secretary's office on 23-8-2016
7. For reasons already recorded above, , the SPIO has prayed for 10 days time to furnish the sought for informations to the petitioner.
8. Time as prayed for is granted and fix 2-2-2018, 1.00 P.M for review of compliance.
