**O R D E R**  
**14-11-2017**

1. The appellant/petitioner Sri Joydeb Das is present. The public authority is represented by Sri Pradip Buragohain, SPIO and G.M (F&P) of ASCL accompanied by Sri Gunjanan W.Syam. ASPIO of ASCL .
2. The review of compliance of this Commission's previous order dated 9-10-2017 is taken up in presence of both the parties.
3. The petitioner submitted orally that he has since received the required informations to his satisfaction in respect of RTI petition relating to educational qualifications of Smti P.Hazarika, Administrative Officer of ASCL. It being so this RTI petition and subsequent second appeal petition dated 12-5-2017 and 21-8-2017 respectively on this issue is , therefore, disposed of and the matter is treated as closed.

As regards other three RTI petitions, all dated 12-5-2017 relating to high breed vegetable seeds, high breed watermelon seeds and certified seeds of black gram variety PU-31 during the year 2016-2017 , the petitioner has been furnished information in respect of high breed vegetable seeds, receipt of which he has acknowledged, except copy of market verification report which the G.M (M&B) of ASCL has stated to be not available.

4. This Commission, therefore, directs the G.M (M&B) of ASCL who is treated as deemed PIO for this second appeal case to hand over to the petitioner within 10 days from the date of receipt of this order , whether there existed at any stage any market verification report in respect of procurement of high breed vegetable seeds during the year 2016-2017 and if it existed, then what happened to it.
5. Coming to procurement of seeds of black gram variety PU-31 the General Manager (M&P) vide his letter dated 14-11-2017 has informed the petitioner that in 2016-2017 there was no indent for supply of black gram variety P-31 from the indenting authorities. The ASPIO of ASCL submitted orally that e-tendering and price finalization of black gram variety PU-31 were done. So they would be able to furnish the documents in respect of :-

- (a) Price finalization Committee report
- (d) Price verification report and
- (e) copy of the e-tendering .

6. Since there was no indent from the indenting authorities, informations in respect of point No. b ,c, and e of the RTI petition are not available. The G.M (M&P) who is treated as deemed PIO for this purpose is , therefore, directed to furnish available informations , as above, to the petitioner within 10 days from the date of receipt of this order.

7 The ASPIO submitted orally that all the informations in respect of watermelon during 2016-2017 are being handed over to the petitioner today. The petitioner also agreed to this suggestion.

8. With the above order the second appeal petition dated 21-8-2017 is disposed of.
