> <u>O R D E R</u> 13-11-2017

- The appellant/petitioner Sri Dulal Bora is present. The public authority is represented by (1) Sri Bishnu Kamal Bora, ACS, SPIO and Joint Secretary of Political Department (2) Smti Keerthi. J, Staff Officer to Chief Secretary, Assam (3) Sri Biju Prasad Baruah, Suptdt. Political (Vigilence Cell) Department and (4) Sri Awadh Kumar, Jr. Administrative Assistant (Vigilance Cell) Department.
- 2. The second appeal petition dated 24-7-2017 is taken up for hearing with reference to the appeal petition dated 9-8-2016 in presence of both the parties
- From perusal of the case records it is seen that the petitioner submitted an application dated 5-12-2014, containing some allegations about some police officials of Guwahati City.
- 4. Vide his RTI petition dated 9-8-2016 the petitioner wanted to know the actions taken on his allegation petition dated 5-12-2014.
- 5. From perusal of case records it is seen that the SPIO of Chief Secretary's office, Assam transferred the RTI petition to the Joint Secretary and SPIO of Home Department. The second appeal petition has been necessitated due to non receipt of any response to the petitioner's RTI petition and consequent First Appeal petition dated 16-5-2017. It is seen that the copy of the original allegation petition dated 5-12-2014 which has been enclosed with the second appeal petition is incomplete and without any signature of the petitioner.
- 6. This Commission, therefore, directs the petitioner Sri Dulal Bora to furnish a complete copy of his original complaint petition dated 5-12-2014 with his signature to the SPIO of Home Department for taking necessary action. The SPIO of Home Department is also directed to furnish appropriate reply to the RTI petition within 30 days from the date of receipt of the allegation petition dated 5-12-2014 from the petitioner.
- 7. With the above order the second appeal petition dated 24-7-2017 is disposed of.
