1. The appellant/petitioner Sri Dulal Bora is present. The public authority is represented by (1) Sri Bishnu Kamal Bora, ACS, SPIO and Joint Secretary of Political Department (2) Smti Keerthi. J, Staff Officer to Chief Secretary, Assam (3) Sri Biju Prasad Baruah, Suptdt. Political (Vigilance Cell) Department and (4) Sri Awadh Kumar, Jr. Administrative Assistant (Vigilance Cell) Department.
2. The second appeal petition dated 24-7-2017 is taken up for hearing with reference to the appeal petition dated 9-8-2016 in presence of both the parties
3. From perusal of the case records it is seen that the petitioner Sri Dulal Bora submitted an allegation petition dated 7-3-2015 relating to the assets and liabilities of Sri Biren Deka, the then O.C of Dispur Police Station and his family members.
4. Vide his RTI petition dated 9-8-2016 the petitioner wanted to know the actions taken on his allegation petition. The SPIO of Chief Secretary's office transferred the RTI petition dated 9-8-2016 to the SPIO of Home Department, Govt. of Assam, who in turn transferred it to the SPIO of Political Department. The SPIO of Political Department who is present today prayed for 30 days time to furnish the appropriate informations to the petitioner.
5. Time as prayed for is granted with the direction that appropriate informations should be furnished to the petitioner within 30 (thirty) days from the date of this order, which was pronounced in presence of both the parties.
6. With the above order the second appeal petition dated 24-7-2017 is disposed of.
