**O R D E R**

The petitioner Shri Utpal Das is present. The public authority to be represented by the SPIO of the Transport Department and Shri Prasenjit Kumar Ghosh, District Transport Officer (DTO), Kamrup (M) are absent. However, the DTO has sent a written submission dated 28.12.17, which is entered into the case records. In his WS, the DTO (Registration) has submitted that in pursuance of this Commission's previous order dated 20.11.17, he wrote to both the technology companies namely OLA and UBER asking for informations about their services in Guwahati city. The DTO has enclosed copies of both the letters with his WS. The DTO has further mentioned that he has received a response from UBER, copy of which has been enclosed with the WS. Reply from OLA is still awaited. The Registry of this Commission is directed to furnish a copy of the WS along with its enclosures to the petitioner.

Issue notice to the DTO (R), Kamrup (M), Betkuchi, Guwahati to be present on that day. Meanwhile, if he receives reply from OLA, then he will furnish copies of the same to the petitioner immediately. On the next date of hearing, the petitioner will submit a written statement stating whether he is satisfied with the informations received, and if not, then he will specify which part of the informations received he is not satisfied with and also point out if any part of the informations sought for by him have not been furnished.
