**O R D E R**

The petitioner Shri Dulal Bora is absent. He has, however, informed the Registry of this Commission that he will not be able to attend the hearing today due to his being out of station. He has not submitted any prayer for deferment of today's hearing. The public authority is represented by Shri Mridul Kumar Mahanta, ACS, Joint Secretary and SPIO, Home and Political Department, Dispur Guwahati-6 accompanied by Shri Awadhesh Kumar, Junior A.A. of the Political Department. Review of compliance of this Commission's earlier order dated 8.11.17 is taken up ex-parte in the absence of the appellant.

The SPIO and Joint Secretary, Political Department, who is present today, prayed for some more time to comply with this Commission's earlier order dated 8.11.17. In continuation of its earlier order mentioned above, this Commission is of the view that the RTI petitioner has raised an important matter of public interest, namely, functioning of the Vigilance Administration in the State. The Commission also notes that the Chief Secretary is the head of Vigilance Administrative hierarchy in the State. As prayed for by the SPIO of Political Department, 30 days' time is granted with the direction that the sought for informations bringing out the present state of functioning of Vigilance Administration in the State shall be furnished to the petitioner, with copy to the Registry of this Commission, within 30 days from the date of receipt of this order, with appraisal of the Chief secretary, Govt. of Assam.
