The petitioner Shri Sarbeswar Kalta is present. The public authority is represented by the Shri Khabiruddin Ahmed, Principal, Barigog Hajo H.S. School and Shri Suresh Ch. Sarma, Planning & Statistical Officer of the office of the Inspector of Schools, Kamrup, Amingaon.

The Principal Barigog Hajo H.S. School has submitted a written statement dated 8.1.18 that the information sought for by the petitioner was furnished to him through speed post on 25.9.17 and the copy of the same was submitted to the Inspector of Schools, KDC, Amingaon. In the WS the public authority has referred to incomplete documents submitted by the petitioner for selection to the post of Principal and has referred to court cases and orders of the Hon'ble Gauhati High Court.

On perusal of the RTI petition dated 28.7.17 it appears that the petitioner has sought for information on five points which do not relate to any High Court case. The public authority present stated that the information sought for by the petitioner was furnished to the petitioner. The petitioner present denied to have received the information sent to him through speed post. The public authority present hand over copies of documents sent to him by obtaining a receipt from the petitioner. Since the information had been furnished by the public authority and received by the petitioner, the second appeal petition dated 9.10.17 is disposed of.
