**O R D E R**

The petitioner Shri Durgeswar Das is absent without any intimation. The CDPO, Barhampur ICDS Project, Dist. Nagaon vide letter dated 25.1.18 had informed that he will not be able to attend the hearing on 29.1.18 due to urgent NRC duty and has authorized Shri Karunmani Pathak, Statistical Assistant to appear on his behalf. He has also informed that Shri Durgeswar Das was informed vide letter dated 23.5.17 that the information sought for by him would be provided and that vide letter dated 27.6.17 the petitioner was informed to deposit an amount of Rs. 2500.00 as photocopy charges of the documents sought for. A reminder was sent to him referring to letter dated 27.6.17 that the petitioner had not deposited the amount of Rs. 2500.00 till date. The public authority present stated that the petitioner in spite of receipt of notices did not deposit the amount or made any communication with them in this regard.

The Commission therefore, directs the petitioner to deposit the photocopy charges of the documents sought for within 21 days from the date of receipt of this order and the public authority is directed to furnish him the documents on receipt of the photocopy charges immediately.
