**O R D E R**  
03.01.2018

The petitioner Shri Mukesh Saikia has informed that he will not be able to attend the hearing today for unavoidable circumstances. He has sent a letter dated 3.1.18 that he had received information on two points, but he has yet to receive information on the points referred to by him at para 'B'. As requested, the public authority present was handed over a copy of the same. The public authority is represented by Shri Pradeep Kr. Nunisa, Accountant, Kapili Development Block, Morigaon. He furnished a copy of the letter addressed to the petitioner dated 21.11.17 requesting him to inspect the records and documents sought for vide his RTI petition dated 31.10.15 in the office of the BDO during office hours as the documents are voluminous. He orally submitted that the petitioner did not visit their office nor made any written communication in this regard.

The Commission, therefore, directs the petitioner to visit the office of the BDO for inspection of documents within 15 days from the date of receipt of this order. The BDO, Kapili Development Block is also directed to allow the petitioner to inspect the documents within 15 days from the date of receipt of the order. The petitioner will inform the BDO of his visit three days prior to his visit. The BDO will allow him to inspect the documents and furnish 20 copies of documents free of cost and thereafter on payment of Rs. 2.00 per page as photocopy charges.

With the above direction, the second appeal petition dated 10.5.16 is disposed of.
