**O R D E R**

The appellant Shri Rajib Deka is present. The public authority, i.e., Assam Seeds Corporation Ltd. (ASCL) is represented by the General Manager and SPIO, Shri Pradip Buragohain. The second appeal petition dated 21.7.17 is taken up for hearing in presence of both the parties.

The petitioner submitted orally that he has not received any response to his RTI petition dated 17.5.17, which was followed by first appeal petition dated 19.6.17. The SPIO of ASCL has submitted orally that the RTI application was transferred to the concerned section, i.e., the marketing section of ASCL. The SPIO further submitted that he has not been able to furnish the sought for information due to non-receipt of the sought for information from the marketing section. This Commission directs the SPIO to formally seek assistance from the concerned officers of the marketing section u/s 5(4) of the RTI Act, 2005 so as to make such officer the deemed PIO u/s 5(5) of the RTI Act, 2005. The SPIO is further directed to furnish the sought for informations to the petitioner within 20 days from the date of this order, which was pronounced in presence of both the parties.
