## <u>ORDER</u> 6.10.2017

The petitioner Shri Narendra Nath Sarma is present. The public authority to be represented by the District Elementary Education Officer (DEEO), Bongaigaon and the first appellate authority is absent without any intimation.

On perusal of the records it is seen that information sought for by the petitioner vide sl. 1 to 6 has been furnished by the DEEO, Bongaigaon and received by the petitioner on 2.8.17. The petitioner filed his second appeal petition on 24.8.17 stating that the reply furnished by the DEEO, Bongaigaon was not complete. The petitioner present stated that he had not received information on the medium of instruction in which the 49 teachers transferred vide order dated 12<sup>th</sup> May, 2017 had studied and whether teachers can be transferred from one medium to the same medium, if not, how three teachers could be transferred. The DEEO, Bongaigaon has informed that the Director of Elementary Education had made the process.

On perusal of documents it appears that the Director of Elementary Education, holds the information sought for by the petitioner. The concerned official of the office of the Director of elementary Education who is holding the information is considered as the deemed PIO u/s 5(4) and 5(5) of the RTI Act, 2005 and is directed to furnish the information within 30 days from the date of receipt of the order.

With the above direction, the second appeal petition dated 24.8.17 filed by the petition is disposed of.
