## <u>ORDER</u>

## 10.10.17

The petitioner Shri Debeswar Rabha is present. The public authority is represented by Dr. Prasanta Barman, Deputy Registrar and PIO of the Gauhati University. The second appeal petition dated 3.5.17 read with the RTI application dated 8.3.17 is taken up for hearing in presence of both the parties.

From the RTI petition dated 8.3.17 it is seen that the petitioner wanted certified copy of the answer script as well as the mark sheet bearing Roll 14096 No. 0406 of the revaluated Political Science of 4<sup>th</sup> semester, 2016. Not getting reply from the SPIO he filed the first appeal petition dated 19.4.17 before the first appellate authority of GU followed by second appeal petition dated 3.5.17 before this Commission. The SPIO submitted before this Commission a copy of his letter dated 25.5.17 addressed to the petitioner stating that as per university records the candidate did not apply for Xerox copy of the revaluated answer script when she paid revaluation fees of an amount of Rs. 700.00 on 8.9.16. The petitioner was informed that for getting Xerox copy of the revaluated answer script an additional amount of Rs. 100.00 have to be paid separately. From plain reading of the letter of the PIO it appears that if the petitioner/candidate pays the additional amount of Rs. 100.00 separately, then Xerox copy of the revaluated answer script will be available. The petitioner submitted that she scored 19 marks out of 100. He applied for revaluation on 8.9.16 and on the body of the money receipt dated 8.9.16, the revaluated mark was shown as 06, implying that after revaluation marks scored by the candidate for Political Science paper came down from 19 to 06. The SPIO sought some time to verify the correct position and to ascertain whether relevant answer script is still available. He is granted time till 12 noon tomorrow to verify the facts and submit an affidavit stating whether the relevant answer script is available or not for furnishing the same to the petitioner. This order was pronounced in the presence of both the parties.
