## ORDER

6.10.17

The petition Mr. Almash Abu Bakar is present. The public authority i.e. Assam Power Distribution Co. Ltd. (APDCL) is represented by Smti. Pooravi Nath, Sun-Divisional Engineer (SDE), Fancy Bazar Electrical Su-Division, Guwahati The second appeal petition dated 22.8.17 is taken up for hearing in presence of both the parties.

From perusal of the case records it is seen that after filing his RTI petition dated 11.5.17 before the SPIO of APDCL, he filed a first appeal petition dated 28.6.17 before the Managing director of APDCL, who passed his order dated 11.7.17 directing the SDE, Fancy Bazar Electrical Sub-Division to furnish the information to the petitioner urgently if, not already furnished.

The SDE of Fancy Bazar Electrical Sub-Division submitted a copy of her letter dated 4.10.17 addressed to the petitioner Mr. Almash Abu Bakar. Vide that letter she furnished point-wise informations to the petitioner, which was received by him on 5.10.17.

From perusal of the RTI petition it is seen that the informations sought for by the petitioner related to enhancement of the connected load of M/S Oriental Marketing Corporation. The gist of the SDE's reply to the RTI petition is that the above mentioned firm/consumer has been continuing with the original connected load without any enhancement for the past 25 to 30 years.

The petitioner, however, submitted orally that according to his information M/S Oriental Marketing Corporation applied for and granted enhancement of their connected load by APDCL, although he could not produce any documentary evidence to that effect today.

In view of this original contention as mentioned above, the petitioner will be at liberty to approach this Commission and or the higher authorities of APDCL with documentary evidence in support of his contention.

With the above order the second appeal petition dated 22.8.2017 is disposed of.
