O R D E R 13.11.17

The petitioner Shri Dulal Bora is present. The public authority is represented by:- (i) Shri Bishnu Kumar Bora, Joint Secretary and SPIO of Political Department, Govt. of Assam, Dispur, (ii) Smti. Keerthi. J., Staff Officer to Chief Secretary, Assam, (iii) Shri Biju Prasad Baruah, Superintendent, Political (vigilance Cell) Department, Government of Assam, Dispur, and (iv) Shri Awadhesh Kumar, Jr. Administrative Assistant, Political (Vigilance Cell) Department, Government. of Assam, Dispur. The second appeal petition dated 24.7.17 read with RTI petition dated 9.8.16 is taken up for hearing in presence of both the parties.

From perusal of the case records it is seen that the petitioner filed an allegation petition dated 23.11.15 lodging some allegations against Shri Hemanta Saikia, Deputy Superintendent of Police. This was followed by his RTI petition dated 9.8.16 filed before the Chief Secretary seeking informations about action taken on the allegation he made. The RTI petition was transferred by the SPIO of Chief Secretary's office vide letter dated 18.8.16 to the SPIO of Home Department. The SPIO of Home Department who is present today submitted that the sought for informations related to the office of the Director General of Police (DGP), Assam and accordingly it was transferred to the DGP, Assam with copy to the petitioner. The petitioner submitted that no information has been received from the DGP, Assam so far.

In view of the above, the Director General of Police, Assam is directed to furnish the sought for informations to the petitioner within 30 days from the date of receipt of this order.

With the above, the second appeal petition dated 24.7.17 is disposed of.
