The petitioner Shri Dulal Bora is absent without any information. The public authority is represented by Shri Mridul Kumar Mahanta, ACS, Joint Secretary and SPIO of Home & Political Department, accompanied by Shri Buju Pr. Baruah, Superintendent, Political (Vigilance Cell) Department and Shri Saurav Mitra, Sr. Administrative Assistant, Home (A) Department. Staff Officer of the Chief Secretary has sent a written statement dated 14.11.17 informing about her absence from the headquarter on official duty and authorised Shri Pancham Pawe, Sr. A.A. of Chief Secretary's office to represent her. The second appeal petition dated 24.7.17 is taken up for hearing ex-parte in the absence of the petitioner.

From perusal of the records it is seen that the petitioner Shri Dulal Bora submitted a complaint petition dated 5.3.16 before the Chief Secretary, Government of Assam making several allegations against the then Commissioner & Secretary, PW Department, Shri Mohan Ch. Boro. This was followed by an RTI petition dated 30.7.16 submitted before the Chief Secretary. The SPIO of the Chief Secretary, Assam transferred the RTI petition to: - (i) SPIO of Home Department and (ii) SPIO of Political Department. The SPIO of Home Department submitted orally that they sent the RTI petition to Political (Vigilance Cell) Department vide letter dated 4.5.17 for taking necessary action. The Superintendent of Political (Vigilance Cell) Department, who is present today, could not apprise this Commission about the present position of action taken by them on the RTI petition. The Commission, therefore, directs the SPIO of Political Department to inform this Commission of the action taken by them on or before the next date of hearing.

Fix 12.30 PM on 21.12.17 for next hearing and review of action taken. Issue notice accordingly.
