## O R D E R 26-12-2017

- The appellant/petitioner Sri Dulal Bora is absent. He has ,however, informed the Registry of this Commission that he will not be able to attend the hearing today due to his being out of station. He has not submitted any prayer for deferment of today's hearing. The public authority is represented by Sri Mridul Kr. Mahanta, ACS, SPIO and Joint Secretary, Home and Political Department, Dispur, Guwahati .
- 2. The second appeal petition dated 24-7-2017 is taken up for hearing ex-parte in the absence of the petitioner.
- 3. From perusal of the case records it appears that the petitioner Sri Dulal Bora filed a complaint petition dated 3-12-2015 before the Chief Secretary to the Govt. of Assam, alleging irregularities committed by M/S Bimal Auto Agency, Guwahati.
- 4. This was followed up by the petitioner by his RTI petition dated 9-8-2016 filed before the PIO of the office of Chief Secretary
- 5. The case records reveal that the RTI petition was transferred by the PIO of Chief Secretary's office to the Joint Secretary and SPIO of Home Department vide letter dated 24-8-2016. Thereafter , the petitioner filed his first appeal petition dated 16-5-2017 before the PIO of Chief Secretary's office and second appeal petition dated 24-7-2017 before this Commission.
- 6. The SPIO and Joint Secretary, Home Department prayed for 30 days' time to furnish the sought for informations as available and disclosable under the RTI Act, 2005 to the petitioner. Time as prayed for is granted with the direction that the SPIO of Home Department will furnish specific informations, as disclosable, to the petitioner, within 30 days from the date of receipt of this order **OR** transfer the RTI petition to the concerned public authority within five days from the date of receipt of this order, whose responsibility it shall be to furnish the sought for disclosable informations to the petitioner within 30 days thereafter.

With the above order the second appeal petition dated 24-

7-2017 is disposed of.
