<u>ORDER</u>

The petitioner Shri Durgeswar Das has informed that he will not be able to attend in today's hearing due to his illness and requested to fix another date for hearing. The public authority is represented by Shri Kamaal Saikia, Head Assistant, Dhing Municipal Board. The Executive Officer, Dhing Municipal Board vide letter dated 14.12.17 has informed that the requisite information sought for by Shri Durgeswar Das on four numbers of RTI petitions dated 28.6.17 had already been furnished to the applicant through registered post.

On perusal of the records it appears that the information sought for by the petitioner was furnished vide letter dated 3.10.17 through registered post and he has furnished a copy of the same. The petitioner was also informed vide letter dated 4.9.17 to collect the information sought for by him from the office of the Executive Officer, Dhing Municipal Board, if not received by him.

In view of the absence of the petitioner it could not be ascertained whether he had received the information. Therefore, the petitioner is directed to collect the information from the office of the Executive Officer, Dhing Municipal Board within 15 days from the date of receipt of this order.

With the above direction, the second appeal petition dated 3.10.17 is disposed of. The petitioner shall be at liberty to file his appeal, in case he is not satisfied with the information furnished by the public authority.
