ORDER 12.12.2017

The petitioner Shri Lalchand Ali Ahmed is present. The Asstt. Executive Engineer, PWD, Mukalmua Rural Road Sub-Division has submitted a written statement that the information sought for vide the RTI petition dated 22.7.17 had already been furnished to him as sought for by para 1 and 2 with a request to contact Shri Manabendra Sarma, JE, PWD and ASPIO for collecting tender agreement, plan and estimate copies. Subsequently, however, the same was furnished to the applicant, after collecting the same from the PWD Division's office the petitioner has acknowledged receipt of the same, which has been enclosed.

Shri Lalchand Ali Ahmed has submitted a petition dated 9.12.17 that he is not satisfied with the information furnished, as letter No. 301 on point No. 3 issue of work order and on point No. 5 letter showing administrative approval was illegible and that the documents were not certified and therefore, he requested the Commission to direct the public authority to furnish the documents in proper manner. During hearing today he has furnished copies of work order and administrative approval issued by the public authority to him. On perusal of the same it appears that copy of administrative approval issued is not legible, but the copy of the work order issued was legible. The petitioner stated that the forwarding letter issued by the Asstt. Executive Engineer, PWD used seal and signature of the Asstt. Executive Engineer wherein the numbers of pages furnished to him were mentioned and he was directed to deposit Rs. 354.00 as photocopy charges. But the public authority did not take the amount and furnished him the documents free of cost. He stated that he would be satisfied if he is furnished a legible copy of the administrative approval issued by the PWD vide letter dated 22.1.16. The Commission therefore, directs the public authority to furnish a legible copy of the administrative approval issued by the public authority to the petitioner within 10 days from the date of receipt of this order.

With the above direction, the second appeal petition dated 7.10.17 is disposed of.
