O R D E R
10-1-2018

1. The appellant/petitioner Smti Dipa Upadhaya is present accompanied by her husband Sri Eknath Dahal. The public authority is represented by Sri Sailya Kaman , Head Master, Bogiram Panging M.E. School, Dhemaji as authorized by the Inspector of Schools, I/C DEEO, Dhemaji District.
2. The complaint petitions dated 28-9-2015 and 26-12-2016 submitted by the petitioner / appellant complaining against non-compliance of this Commission's order dated 12-8-2015 by the DEEO of Dhemaji district are taken up for consideration in presence of both the parties.
3. The Inspector of Schools and I/C DEEO has sent a written submission dated 2-1-2018 along with enclosures stating that the petitioner Smti Dipa Upadhaya was removed from the post of Asstt. Teacher due to some financial irregularities. The appellant also submitted before this Commission a copy of letter dated 16-7-2016 from the office of DEEO, Dhemaji addressed to Smti Dipa Upadhaya, the petitioner, enclosing a copy of School's Managing Committee's minutes of meeting of the Managing Committee of the School held on 30-6-2010. In that meeting it was resolved to remove Smti Dipa Upadhaya from the post of Asstt. Teacher on grounds of alleged financial irregularities. The allegation against her was that she collected a sum of Rs. 40,000/- from her fellow teachers with the promise of getting their services provincialized, which promise she could not fulfill. The Inspector of Schools and I/C DEEO has submitted a copy of minutes of the meeting of the Managing Committee held on 4-7-2010 whereby one Smti Moni Pegu Doley was appointed against the vacant post of Smti Dipa Upadhaya.
4. From the above, it appears that the DEEO , Dhemaji has complied with this Commission's order dated 12-8-2015 and informed the petitioner/ appellant the reasons why no remuneration was paid to her. Therefore, there does not appear to be any further cause of action before this Commission.

5. Hence, the non-compliance complaint petitions mentioned above are dismissed.
