### O R D E R 21.02.2018

- 1. The petitioner Sri Dulal Bora is present. The public authority is represented by Niranjan Bora, Under Secretary and SPIO of Assam Chief Minister's Secretariat, accompanied by Sri Prabal Jyoti Medhi, Sr. Administrative Assistant of C.M's Secretariat.
- 2. The second appeal petition dated 27-6-2017 is taken up for hearing in presence of both the parties.
- 3. From perusal of the case records, it is seen that the petitioner filed a complaint petition dated 13-2-2016 before the Additional Chief Secretary in the office of the Chief Minister, Assam complaining about long tenure of more than 6 years of one Sri Satya Ranjan Roy, Sr. FAO in the Directorate of Treasuries, Assam
- 4. Thereafter he filed an RTI petition dated 17-8-2016 before the SPIO of Chief Minister's Secretariat seeking the following informations:-
  - (a) The number of the file from which inquiry was ordered into the allegations mentioned in his complaint petition dated 13-2-2016 and name of the Inquiry Officer with his designation;
  - (b) names and addresses of the persons mentioned in the complaint petition dated 13-2--2016, and
  - (c) photo copy of report submitted by the Inquiry Officer to his higher authorities.
- 5. The SPIO of C.M's Secretariat has submitted a written statement. which was enclosed with the written statement dated Nil, stated that CM's Secretariat transferred the RTI petition to the SPIO of Finance Department, a copy of which was given to the petitioner Sri Dulal Bora.. The onus of furnishing the sought for information, therefore, lies with the SPIO of Finance Department. The petitioner may, therefore, file his first appeal petition before the first

appellate authority of Finance Department, if he desires to do so within 30 days from the date of receipt of this order.

- 6. The written statement stated that the same petitioner Sri Dulal Bora submitted 445 Nos. of RTI petitions during the month of August, 2016. Again he submitted 378 Nos. of 1<sup>st</sup> appeal petitions in the months of May-June 2017. The written statement mentioned that Sri Bora was informed that in view of the large No. of RTI petitions and first appeal petitions submitted by him, they will be taken up for consideration in due course.
- 7. The above position taken by the C.M Secretariat does not appear to be in conformity with the relevant provisions of the RTI Act, 2005, which has stipulated clear guidelines for disposal of RTI and first appeal petitions under Section-7 and Section 19 of the RTI Act, 2005. In any case, the informations sought for by the petitioner are very simple
- 8. The SPIO of C.M's Secretariat is , therefore, directed to furnish the informations to the petitioner against point No. (a) and (c) within 15 days from the date of receipt of his order.

With the above order, the second appeal petition dated 27-6-2017 is disposed of..
