O R D E R

1. The petitioner Sri Rajib Deka as well as the Branch Manager of Assam Seeds Corporation Ltd (ASCL) , Karimganj, Sri Birendra Kr. Namasudra, both are present.

2. The second appeal petition dated 16-11-2017 is taken up for hearing in presence of both the parties.

The Branch Manager, ASCL, Karimganj made a written submission dated 3-1-2018 stating that the required information was furnished to the petitioner vide letter No. ASC/KXJ/7/Pt-I/RTI/75 dated 3-1-2018 , copy of which was enclosed with the written statement

3. However, the petitioner submitted that the following informations have not been furnished to him :-

- (i) **Names of the resource persons for the year 2011-2012, 1012-2013 and 2016-2017 in respect of bullet point No. 3 of his RTI petition.**
- (ii) **Names and addresses of growers from whom seeds were purchased in respect of bullet point No. 4 of his RTI petition.**

4. In view of the above, , the Branch Manager, ASCL , Karimganj is directed to allow the petitioner or his authorised representative to inspect all relevant office records on any working day within 15 days from the date of receipt of this order and also allow him to take notes and photocopies of the required documents free of cost up to 25 pages and thereafter, on payment of Rs. 2/- for every additional page of photocopy.

5. The petitioner is directed to give at least 2 (two) days' advance notice for inspection of records to the Branch Manager, ASCL, Karimganj .

6. With the above order, the second appeal petition dated 16-11-2017 is disposed of.
