O R D E R
09.02.2018

1. The petitioner Sri Joydeb Das is present. The public authority to be represented by the SPIO of Agriculture Department, Govt. of Assam is absent without information..
2. The second appeal petition dated 14-12-2017 is taken up for consideration ex-parte in the absence of the SPIO of Agriculture Department.
2. From perusal of the case records it is seen that the petitioner filed an RTI petition dated 11-9-2017 before the SPIO of Chief Secretary, Govt. of Assam seeking informations about the status of action taken on his representation dated 2-5-2017, which was forwarded to the Chief Secretary to the Govt. of Assam by the PMO on 12-5-2017 vide letter No.MOPG/D/2017/0217386. It is seen from the case records that the RTI petition was transferred by the SPIO of Chief Secretary's office to the Joint Secretary and SPIO of Agriculture Department, Govt. of Assam, vide their letter dated 14th September, 2017. Copy of that letter was also given to Sri Joydeb Das, informing him that the PMO letter mentioned above had already been transferred to the Additional Chief Secretary, Agriculture Department, Govt. of Assam from Chief Secretary's dak section vide ECR.No.30965 dated 1-6-2017. The petitioner also produced a copy of the PMO letter mentioned above, forwarding the representation dated 2-5-2017 received from Sri Joydeb Das for action as appropriate with an advice to send a reply to the petitioner and to upload a copy of the reply on the portal.
4. The petitioner also submitted before this Commission a copy of the representation dated 2-5-2017 which he submitted before the Hon'ble Prime Minister of India. In his representation before the Prime Minister the petitioner alleged against

corruption in Agriculture Department, Govt. of Assam. The petitioner submitted orally before this Commission that he has not received any response from the Agriculture Department as yet.

- 5 In view of the above, the SPIO of Agriculture Department, Govt. of Assam is directed to furnish the sought for information to the petitioner within 15 days from the date of receipt of this order.
6. Fix **12.30 P.M , 9-3-2018** for review of compliance of this order. Issue notices to both the parties for their appearance on the next date of hearing.
7. The SPIO of Agriculture Department is further directed to file an affidavit confirming compliance of this order.
