O R D E R 25-1-2018

- The appellant/petitioner Sri Rajib Deka is present. The public authority, namely, Assam Seeds Corporation Ltd. (ASCL) is represented by Sri Harendra Nath Das, I/C Branch Manager of ASCL, Morigaon.
- 2. The petition dated 16-11-2017 filed by the petitioner complaining about non-compliance of this Commission's order dated 13-10-2017 is taken up for consideration in presence of both the parties.
- 3. This Commission by its order dated 13-10-2017 directed the Branch Manager of ASCL, Morigaon to furnish the sought for information to the petitioner within 30 days from the date of that order. The petitioner vide his complaint petition dated 16-11-2017 reported that till then no information was furnished to him. However, in the meantime he has received the sought for informations in respect of the financial year 2016-2017. He is aggrieved that the sought for informations for the period 2011-2012 to 2015-2016 have not been furnished to him.
- 4. The Branch Manager of ASCL, Morigaon made a written submission dated 17-1-2018 which is entered into the case records. In his W/S the present I/C Branch Manager Sri Harendra Nath Das has stated that he took over charge of the office on 3-5-2017. At the time of taking over charge his predecessor handed over records relating to the APRs (paddy) and training attendance sheets for the financial year 2016-2017 only. The I/C Branch Manager stated that attendance sheets for Sali paddy training for the year 2016-2017 have already been furnished to the petitioner, receipt of which was acknowledged by him. The I/C Branch Manager has now prepared the APRs also for the financial years 2016-2017. He is directed to furnish the same to the petitioner within 10 days from the date of this order which was pronounced in presence of both the parties.

- 5. The I/C Branch Manager submitted that other than the office records, his predecessor did not hand over any other records pertaining to the informations sought for by the petitioner vide his RTI petition dated 29-5-2017. Therefore, he expressed his inability to furnish those records.
- 6. This Commission takes a serious note of non-availibility of public records involving expenditure from the state exchequer. Therefore, in exercise of powers under Section 19 (8) (a) of the RTI Act, 2005, this Commission directs the Managing Director of Assam Seeds Corporation Ltd. to cause an inquiry by a responsible officer into the matter of missing records as reported by the I/C Branch Manager of ASCL, Morigaon branch, and report the outcome thereof and action taken thereon within 60 (sixty) days from the date of this order.
- 7. Fix **28-3-2018**, **12.30 P.M** for review of action taken . Enclose a copy of the I/C Branch Manager's statement dated 17-1-2018 to the Managing Director, ASCL along with a copy of this order.
- 8. Issue notices to both the parties and the SPIO of ASCL, Morigaon for their attendance on the next date of hearing.
