1. The appellant/petitioner Sri Joydeb Das is present. The public authority is represented by Sri Pradip Buragohain , General Manager (F&P), of Assam Seeds Corporation Ltd (ASCL) accompanied by Sri Gunjanan Shyam of the same office.
2. The Second appeal petition dated 7-11-2017 is taken up for hearing In presence of both the parties.
3. The petitioner submitted that he is yet to receive the information sought for by his RTI petition dated 27-6-2017 even after his first appeal petition dated 22-9-2017.
4. The SPIO submitted that the petitioner was invited for verification of records which could not take place due to a bereavement in the family of the ASPIO.
5. In view of the above, the SPIO of ASCL is directed to allow the petitioner to inspect all relevant records and documents with reference to his RTI petition dated 27-6-2017 during office hours on any working day within 15 days from the date of this order, which was pronounced in presence of both the parties and allow him to take notes and photocopies of the sought for documents, free of cost up to 25 pages and thereafter on payment of Rs. 2/- for every additional page of photocopy.
