The petitioner Shri Joydeb Das is present. Shri Munna Prasad Rownier, Joint Director of Agriculture and SPIO of the Directorate of Agriculture is also present on behalf of the public authority. The second appeal petition dated 14.12.2017 with reference to RTI petition dated 11.9.17 is taken up for hearing in presence of both the parties.

The SPIO submitted that he advised the petitioner to approach the Assam Seeds Corporation Ltd. (ASCL) to obtain the informations sought for by his RTI petition dated 11.9.17, since the ASCL is the holder of the informations. The petitioner also stated that he approached the ASCL and received part of the informations sought for by him vide letter dated 9.2.18 from the General Manager (M&P), ASCL. He has submitted that he is yet to receive the information for the financial year 2017-18. The General Manager of ASCL told him, as stated by the petitioner, that information for the financial year 2017-18 will be furnished when bills are submitted. In other words information for the FY 2017-18 has not yet been generated. The petitioner may therefore follow up the assurance given to him by the General Manager (M&P), ASCL.

With the above order the second appeal petition dated 14.12.17 is disposed of.
