## ORDER 8.3.18

The petitioner Shri Dulal Bora is present. The public authority is represented by Shri Nirajan Bora, Under secretary and SPIO of Chief Minister's Secretariat (CMS), Assam accompanied by Shri Probal Jyoti Medhi, Sr. Administrative Assistant of CMS. The second appeal petition dated 27.6.17 with reference to RTI petition dated 17.8.16 is taken up for hearing in presence of both the parties.

The concerned SPIO of CMS has submitted a written statement dated 8.3.2018 stating that originally the petitioner Shri Dulal Bora submitted a complaint petition dated 19.2.16 against Smti. Shamsera Hazarika, the then District Social Welfare Officer in Sonitpur district. It was forwarded to the Principal Secretary, Social Welfare Department, Govt. of Assam for necessary action vide UO No. CMS.04/2016/653 dated 29.2.2016. Recently on 6<sup>th</sup> March, 2018, the RTI petition dated 17.8.16 has also been transferred to the SPIO of Social Welfare Department, Govt. of Assam. It appears that there has been delay on the part of both the parties – in filing the first appeal petition of the petitioner and in transferring the RTI petition on the part of the SPIO. However, in transparency, the second appeal petition is accepted and the SPIO of Social Welfare Department, Govt. of Assam is directed to furnish the information sought for by the petitioner vide his RTI petition dated 17.8.16 within 30 days from the date of receipt of the transferred RTI petition. It has now been transferred by the SPIO of CMS to the SPIO of Social Welfare Department, Govt. of Assam.

With the above order, the second appeal petition dated 27.6.17 is disposed of.
