**O R D E R**

The petitioner Shri Dulal Bora is absent without any intimation. The SPIO and Deputy Commissioner of Police, Panbazar has informed the Commission vide letter dated 21.2.18 that the reply was furnished to the applicant vide their office memo dated 19.2.18. OC. He has enclosed a copy of letter dated 15.2.18 from the OC, Dispur Police Station informing the Addl. Deputy Commissioner of Police that the FIR filed by Shri Dulal Bora was sent to the OC, Gossaigaon Police Station on 19.10.15 as the PO falls under Gossaigaon Police Station.

In view of the absence of the petitioner it could not be ascertained whether the petitioner received any information from the OC, Gossaigaon Police Station. Since the matter relates to OC, Gossaigaon Police Station, he is considered as the deemed PIO u/s 5(4) and 5(5) of the RTI Act, 2005 is directed to furnish the information to the petitioner within 21 days from the date of receipt of this order, if not furnished earlier.

On perusal of records it appears that the first appeal petition filed by the petitioner on 4.5.17 before the PIO, Commissioner of Police, Govt. of Assam has not been heard and disposed of by the first appellate authority. The Commission therefore, directs the first appellate authority to hear and dispose the first appeal within a month from the date of receipt of this order.

With the above direction the second appeal petition dated 25.8.17 is disposed.
