The petitioner Dr. Atindra Das is present. The public authority is represented by Dr. Puspendra Bordoloi, SDM&HO of Jhargaon BPHC. The petitions dated 18.11.17 and 27.11.17 filed by the petitioner complaining of non-compliance of this Commission's order dated 6.7.17 by the SDM&HO of Jhargaon BPHC is taken up for consideration in presence of both the parties.

The petitioner produced before this Commission a copy of letter dated 24.10.16 sent to him by the concerned SDM&HO. The petitioner complained that as ordered by this Commission, duly attested copies of the relevant attendance register were not furnished to him against point nos. 1 and 2 of his RTI petition. The SDM&HO present admitted the lapse and assured to furnish attested copies of the relevant attendance register within 7 days from the date of this order, which was pronounced in presence of both the parties.

As regards point nos. 3 and 5 of the RTI petition, the SDM&HO submitted orally that he has transferred the relevant portion of the RTI petition to the Joint Director of Health Services, Morigaon. The petitioner stated that he was not given a copy of the transfer letter. The SDM&HO, Jhargaon BPHC is directed to give a copy of the transfer letter also to the petitioner within 7 days from the date of this order after the stipulated time.

Both the parties are directed to inform this Commission about informations furnished and received immediately.

With the above order, the petitioner's second appeal petition is disposed of.
