O R D E R
29-1-2018

1. The appellant/petitioner Sri Dulal Bora is absent. The public authority is represented by Sri Ananda Kr. Das , Deputy Secretary and SPIO of Revenue and Disaster Management Department. No request for deferment of hearing has been received from the petitioner. His second appeal petition dated 24-7-2017 is , therefore, taken up for consideration ex - parte in his absence.
2. The SPIO cum Deputy Secretary, Revenue and Disaster Management Department submitted a written statement narrating sequentially actions taken by the Revenue and Disaster Management Department.
3. The complaint petition dated 17-6-2015 alleging construction of a residential building (house No. 37) by illegally occupying a plot of Govt. land at Seoj Nagar of Beltola area of Guwahati city by former Minister Sri Akon Bora.
4. In his complaint petition he requested the Chief Secretary to examine all relevant records, particularly permissions of GMC and GMDA, and to seal the residential building allegedly constructed on Govt. land.
5. It is seen from the case records that the RTI petition was transferred by the SPIO of the office of the Chief Secretary, Govt. of Assam to the Deputy Secretary and SPIO of Revenue and Disaster Management Department, with information to the petitioner Sri Dulal Bora, vide letter dated 16th August, 2016. The SPIO of the office of Chief Secretary to the Govt. of Assam had submitted a written statement dated 15th December, 2017, stating that both the RTI petition

and first appeal petition dated 16-5-2017 were since forwarded to the Revenue and Disaster Management Department.

6. The SPIO and Deputy Secretary, Revenue and Disaster Management Department stated that the original complaint petition dated 7-5-2016 as well as

the subsequent RTI petition dated 9-8-2016 and the first appeal petition dated 16-5-2017 do not appear to have been received in the Department. Hence no information has been furnished to the petitioner so far. Now, however, he has the copies of those documents as received with the notice from the Commission.

7 In view of the above, the SPIO and Deputy Secretary, Revenue and Disaster Management Department is directed to furnish the sought for informations to the petitioner within 30 days from the date of receipt of this order.

8. With the above order the second appeal petition dated 24-7-2017 is disposed of.
