<u>O R D E R</u>

The public authority i.e. the Juria Development Block is represented by Md. Hafez Ali, Sr. Gram Sevak and SPIO of Juria Development Block accompanied by Shri Guneswar Saikia, Sr. Assistant (A), Juria Dev. Block. The petitioner Shri Nityananda Goswami is absent. He has sent a written prayer dated 3.2.2018 requesting adjournment of the date of hearing due to his illness.

Earlier by an email dated 6.1.18, the petitioner reported that after this Commission's order dated 5.10.17 the SPIO of Juria Development Block sent some informations to him vide letter dated 6.12.17, which were received by the petitioner on 2.1.18. The petitioner has again complained that the actual informations sought for by him were not furnished with the letter dated 6.12.17. On the other hand, the SPIO of Juria Development Block office also submitted a separate written submission dated 3.2.18 stating that all the sought for informations were furnished to the petitioner vide letter dated 6.12.17 and that he did not understand why the petitioner is not still satisfied.

In view of the difference of opinion between the two parties and the prayer of the petitioner for adjournment of today's hearing due to his illness, fix 12.30 PM on 7.3.2018 for hearing of both the parties. Also furnish a copy of the petitioner's submission vide letter dated 6.1.18 to the SPIO of Juria Development Block by hand today so that he can come prepared with appropriate response in the next date of hearing.

Issue notices to both the parties accordingly.
