Dr. Hemendra Chandra Bhattacharya, Director of Extension Education/SPIO, Assam Agricultural University, Jorhat and Dr. Phuleswar Nath, Head of Krishi Vigyan Kendra, Assam Agricultural University, Sivasagar are present. A Written Statement dated 27.01.2018 submitted by the SPIO.

The Appellant is absent without information.

As the Respondents are present and have submitted Written Statement, the Commission decided to conduct the hearing proceedings *ex parte* of the Appellant.

Perused the Written Statement and heard the Respondents. It has been submitted that the information as available on record has been provided to the Appellant.

Perused the case record. It is seen that the Appellant had submitted his Second Appeal dated 05.11.2017 stating that he was not satisfied with the information provided to him by the SPIO in response to his Application dated 26.08.2017 and First Appeal dated 19.09.2017 and the decision of the First Appellate Authority/Vice-Chancellor, Assam Agricultural University, Jorhat.
