O R D E R 12.01.2018

The Appellant, Shri Chand Mahammad Pradhani is present.

The Respondent absent without information. He has not submitted any Written Statement and also has not explained as to why penalty U/S 20 (1) of the RTI Act, 2005 should not be imposed on him for his failure to furnish the information within the time stipulated.

In the absence of the Respondent and any Written Statement received from him, the Commission could not determine as to whether his First Appeal dated 22.07.2017 was disposed of.

As the Appellant is present and the hearing was notified sufficiently in advance, the Commission decided to conduct the hearing proceedings *ex parte*.

Perusal of the case record indicates that the Respondent had indeed furnished information twice to the Appellant in response to his Application dated 28.03.2017 through letters dated 21.04.2017 and 19.05.2017. The Appellant had submitted his Second Appeal dated 03.11.2017 stating that the documents provided to him did not bear seal and signature and was incomplete.

Heard the Appellant. He submitted that in respect of point number 1 of his Application of the complete lists of the schemes has not been provided and out of 740 beneficiaries of sprayer machines under the BGREI the names of only 530 have been mentioned, as regards the point number 5, the beneficiaries lists with their bank account numbers ware required in respect of what he called DBT systems.

In view of the facts brought out above, the Commission hereby orders that the Respondent shall review the information already provided, and provide the wanting information as specified by the Appellant, free of cost, within 10 days of receiving this order.

The Second Appeal is hereby disposed of.
