The petitioner Shri Abul Fazal Barbhuiya is present. The Public Authority is represented by the Block Development Officer, Hailakandi and the 1st Appellate Authority by the C.E.O., Zilla Parishad are absent without any intimation.

On perusal of the RTI petition dt. 2-8-2016 it is seen that the petitioner has sought for details of sanction and guidelines of MNREGA, BRGF, DDP, TFC, Fourteen Finance and all other funds received under all the G.P. and A.P. of Lala Dev. Block. He sought for details of plan, estimate, progress report, J.E's reports, U/C etc. of all scheme implemented yearwise for the period of 2013-14 to 2015-16.

The Commission observes that the information sought for by the petitioner vide his RTI petition dt. 2-8-2016 involve huge volume of information relating to several categories of information for several years. Furnishing of complete information by making photocopies would involve sufficient cost. The Commission therefore directs the petitioner to inspect the relevant

records and documents in the office of the B.D.O. Lala within 21 days from the date of receipt of this order and complete inspection of document during office hours. The petitioner will give at least two days notice to the Public Authority for inspection of documents.

The B.D.O. Lala is directed to show cause as to why penal action shall not be taken against him for not furnishing the information to the petitioner and not responding to the notice issued by the Commission. He is also directed to allow the petitioner to inspect the records and documents and allow him to take notes and photocopies of the documents sought for free of cost up to 50 copies and thereafter on payment of actual cost of photocopies.

The petitioner Shri Komrul Haque Laskar is present. The Public Authority to be represented by the Block Development Officer, Hailakandi Development Block and the C.E.O., Zilla Parishad as 1st Appellate Authority are absent without any intimation. The 2nd Appeal petition filed by the petitioner dt. 4-10-2017 is taken up for hearing exparte. On perusal of record it appears that the petitioner filed his R.T.I. petition before the B.D.O., Hailakandi on 19-8-2016 due to non-receipt of information. He filed his 1st Appeal before the C.E.O. Zilla Parishad on 26-7-2017 and the C.E.O., Zilla Parishad vide letter dt. 5-8-2016 directed the B.D.O. Hailakandi to furnish the required information to the petitioner within 7 days. The petitioner present stated that he had not received any information.

On perusal of case record the Commission observes that the information sought for by the petitioner vide his R.T.I. petition dt. 19-8-2016 involves a huge volume of information relating to several categories of information for the period 2012-13 to 2015-16. Furnishing of complete information by making photocopy will require compilation of information and involve substantial cost in making photocopies.

The Commission therefore directs the petitioner to inspect the relevant record and documents in the office of the B.D.O., Hailakandi within 21 days from the date of receipt of this order and complete inspection of document during office hours within 2 working days. The petitioner will give 2 days prior notice to the Public Authority for inspection of document.

The B.D.O., Hailakandi is also directed to allow the petitioner to inspect the relevant document as above and allow him to take notes and photocopy of the documents sought for free of cost up to 25 copies and thereafter on payment of Rs. 2/- for every additional page of photocopy.

With the above direction the 2nd Appeal petition dt. 4-10-2017 is disposed of.

The petitioner Shri Sahab Uddin Choudhury is present. The B.D.O., Hailakandi has submitted a written statement dt. 3-10-2017 with reference to order dt. 30-8-2017 that the petitioner Shri Sahab Uddin Choudhury had filed his 1st Appeal before the B.D.O. Hailakandi due to non-receipt of information from the Secretary, Gaon Panchayat, Bahadurpur and hearing of the 1st Appeal was fixed on 23-3-2017 where the petitioner was present. The P.I.O, Secretary, Bahadurpur Gaon Panchayat was absent without taking any step and he was directed to furnish

the required information to the petition on or before 7-4-2017. The B.D.O. has also stated that he had submitted a written statement dt. 11-5-2017 with reference to the notice of the Commission dt. 19th April, 2017. With reference to order dt. 17-5-2017, he directed the Secretary, Bahadurpur to furnish the information to the petitioner within 28-7-2017 without fail. He also stated that notice addressed to the G.P. Secretary, Bahadurpur Gaon Panchayat was neither received nor refused by the office of the B.D.O., Hailakandi. He has furnished the postal

address of the Secretary, Gaon Panchayat. He also stated that on receipt of order dt. 30-8-2017, he had instructed the Secretary, Gaon Panchayat again to furnish the information to the petitioner on or before 8-10-2017. He also stated that the P.I.O. Secretary, Bahadurpur Gaon Panchayat is the custodian of record and the Controlling Officer of all Gaon Panchayat Secretaries is the Chief Executive Officer, Zilla Parishad, Hailakandi and the C.E.O., Zilla Parishad, Hailakandi has also been informed of the matter. As such he has requested to exempt him for the aforesaid appeal and requested to impose penalty on the Gaon Panchayat, Bahadurpur.

In view of the facts stated above, this Commission orders as follows.

Notice be issued to the Gaon Panchayat Secretary of Bahadurpur in the address furnished by the B.D.O., Hailakandi. The Gaon Panchayat Secretary is directed to furnish the information to the petitioner within 21 days from the date of receipt of this order as it seems that notices issued by the Commission were not received by him.

In view of the clarification furnished by the B.D.O., Hailakandi that the Controlling Officer of the Gaon Panchayat Secretary is the Chief Executive Officer of the Zilla Parishad, the Commission directs that a copy of the 1st Appeal submitted to the B.D.O., Hailakandi be sent to C.E.O., Zilla Parishad, Hailakandi for hearing and disposal of the matter within 30 days from the date of receipt of the order.

With the above direction, the 2nd Appeal petition dt. 8-4-2017 is disposed of.

The petitioner Smt. Noorjahan Begom Mazumder is absent. The in-charge, Block Elementary Education Officer, Cachar and SPIO vide his written statement dt. 17-11-2017 informed that he had sent all related records of Late Abdul Mannan, Asstt. Teacher of Jirighat Abhinash Mitra M.E. School, who retired and expired during suspension in the year 2002 and 2011 respectively for release of his arrear salary and pensionary benefit to the D.E.E.O. on 25th May, 2016. The then D.E.E.O., Cachar sought for permission for reconstruction of Service Book vide letter dt. 31-12-2016. But no communication was made by the Higher Authority regarding the matter. He also stated that he had informed the petitioner of the matter. Under the above circumstances, he has requested to exempt him from the charges and also to exempt him from attending the hearing scheduled on 22-11-2017 due to his illness.

The District Elementary Education Officer vide mail dt. 22-11-2017 has requested to exempt him from personal appearance today, as he was entrusted with implementation of Barak Namami Programme for last seven days. He also stated that in view of the above, he could not

dispose the case in time. However, immediate measure will be taken to dispose the matter for re-instatement of teacher and providing provisional pension to the family.

The Commission vide order dated 16-10-2017 had directed the SPIO and Head of office of the D.E.E.O, Cachar to take immediate steps to resolve the matter under Sec. 54-B of F.R. and furnish the information to the petitioner within 21 days from the date of receipt of the order. He was also directed to show cause by penalty under Sec. 20 of the R.T.I. Act, 2005 shall not be imposed on them for withholding the above vital information from the petitioner and also to show cause as to why appropriate compensation shall not be ordered in favour of the petitioner for financial losses and other harassment suffered for non-furnishing of information.

The Commission observes that the SPIO and Block Elementary Education Officer, Cachar had submitted all relevant documents to the D.E.E.O., Cachar for release of arrear salary of pensionary benefit vide letter dt. 25-5-2016 and also informed the petitioner of the status vide letter dt. 16-2-2017. The D.E.E.O., Cachar has not taken steps to resolve the matter U/S. 54-B. The question of provisional pension does not arise. He has not replied to the show cause as to why penalty under Sec. 20 of the R.T.I. Act, 2005 shall not be imposed on him for withholding the above vital information to the petitioner and also to show cause as to why appropriate compensation shall not be ordered in favour of the petitioner for financial losses and other harassment suffered for non-furnishing of the information by the D.E.E.O. The D.E.E.O. Cachar is given a last opportunity to reply to the show cause issued vide order dated 15-10-2017. The written reply indicating clearly date of receipt of R.T.I. petition and date of furnishing record to the applicant shall be submitted to the Commission at the time of hearing when the D.E.E.O., Cachar shall be heard in person before passing order to that effect.

The D.E.E.O. Cachar will also inform the petitioner latest by 4th January, 2018 about details of action taken with regard to her prayer for release of retirement benefits as well as

The petitioner Shri Raju Roy is present. The Public Authority to be represented by the B.D.O., Algapur Dev. Block is absent without any intimation. The Commission has decided to go ahead with today's (20-11-2017) hearing exparte in the interest of the applicant in accordance with the provisions of the R.T.I. Act, 2005.

On perusal of records, the Commission observes that the information sought for by the petitioner vide his R.T.I. petition dt. 26-4-2017 involves a huge volume of information relating to several categories of information for several years for the period 2013 till 2018. Furnishing of information by making photocopies will require compilation of information and substantial cost for making photocopies of various scheme like PMAY, IAY etc. This will definitely lead to huge burden on the man power and resources of the concerned Public Authority.

The Commission therefore, directs the petitioner to inspect the relevant office records and documents in the office of the B.D.O., Algapur within 21 days from the date of receipt of this order and complete inspection of documents during office hours.

The B.D.O. Algapur is also directed to allow the petitioner to inspect the relevant records and documents as above and allow him to take notes and photocopies of the documents free of cost up to 25 copies and thereafter on payment of Rs. 2/- for every additional page of photocopies.

With the above direction, the 2nd Appeal petition dt. 2-8-2017 is disposed of.
