**O R D E R**

9.3.18

1. The petitioner Shri Joydeb Das is absent without any information. The public authority is represented by:- (1) Shri Hitesh Sarma Medhi, SPIO of Guwahati Metropolitan Development Authority (GMDA) accompanied by Shri Phulen Saharia, Jr.A.A., GMDA and (2) Shri Niroda Kumar Choudhury, SPIO of Managing Director, Guwahati Metropolitan Drinking Water and Sewerage Board, Guwahati Jal Board accompanied by Shri Mrinal Sharma, Office Assistant of the Board.
2. The SPIO of GMDA Shri Hitesh Sarma Medhi has submitted an affidavit dated 8.3.18 stating, inter alia;
  - (a) that the petitioner has been furnished the sought for information vide letter no. GMDA/RTI/2016/187/17 dated 15.12.17, and
  - (b) that the informations sought for by the petitioner have also been uploaded in GMDA's website [www.gmda.assam.gov.in](http://www.gmda.assam.gov.in) on 7.3.18. In other words, GMDA has fully complied with the orders dated 9.2.18 passed by this Commission.
3. The SPIO of Guwahati Jal Board, i.e., Guwahati Metropolitan Drinking Water and Sewerage Board has furnished a written statement dated 9.3.18 praying for extension of time to comply with this Commission's order dated 9.2.18 in view of their manpower shortage. He submitted orally that otherwise there is no problem in complying with the Commission's order dated 9.2.18. **Time as prayed for is granted till 20<sup>th</sup> April, 2018** with the direction that the SPIO of Guwahati Jal Board will report compliance before the date.
