1. The petitioner Shri Dulal Bora is present. The public authority is represented by:- (1) Shri Ananda Kr. Das, Deputy Secretary and SPIO of Revenue & Disaster Management Department, Govt. of Assam, (2) Shri Prasanta Protim Kathkotia, Addl. Deputy Commissioner and SPIO of the office of the Deputy Commissioner, Kamrup (M) and (3) Dr. Dhruba Jyoti Hazarika, ACS, Circle Officer, Sonapur Revenue Circle accompanied by Shri Robin Ch. Terang, Jr. Assistant of Sonapur Revenue Circle. The second appeal petition dated 24.7.17 is taken up for further consideration in pursuance of this Commission's earlier orders, the last but one being of 27.2.18.

2. The Circle Officer (CO) of Sonapur Revenue Circle has submitted a copy of his letter dated 21.3.18 addressed to the petitioner Shri Dulal Bora furnishing him the sought for information. The SPIO and Deputy Secretary of Revenue & Disaster Management Department, Govt. of Assam has also submitted a separate WS stating, inter alia, that necessary information has been furnished to the petitioner. The petitioner also gave an undertaking stating that he has received the sought for information from the concerned public authorities to his satisfaction.

In view of the above, there seems to be no further cause of action, and hence the second appeal petition dated 24.7.17 is disposed of.
