ORDER 21-03-2018

The petitioner Sri Chandra Sekhar Sarma is present. The public authority is represented by Sri Hitesh Sarma Medhi, SPIO, GMDA, Smt. Alin Begum, SPIO, E.E., GMC, assisted by Sri Phulen Saharia, Jr. Asstt. GMDA and Sri Jitu Ballav Dutta, UDA, GMDA. The SPIO, GMDA, Bhangagarh has submitted an action taken report on the RTI application filed by Sri Chandra Sekhar Sarma on 27-7-2016 and his subsequent Appeal petition dt. 27-9-2016. He has stated that the building permission cell of GMDA could not trace any information with the particulars given by the applicant and the petitioner was informed vide letter dt. 6-8-2016 that no record of any building permission cell in the name of Subham Group and Lohia Group were found in the computerized data base maintained since 2008. The petitioner was requested to furnish the complete File No., name of NOC holder, details of land i.e.dag no., patta no. and revenue village to trace up record of building/ planning permission. On receipt of 1st Appeal petition Dated 27-9-2016 he was informed vide letter dt. 1-10-2016 of the same status. He orally submitted details of land particulars were necessary for providing the information.

The petitioner orally submitted that details of File No. of the office would be available with the public authority, but he would furnish details of land particulars to the public authority shortly.

In view of the above the Commission directs the applicant to furnish the details of particulars of land to the public authority within 15 days from the date of receipt of this order. The public authority is also directed to furnish the information sought for by the Applicant within 30 days from the date of receipt of details from the applicant.
