# ORDER 09-03-2018

The Petitioner Sri Dulal Bora is present. The Public Authority to be represented by the Transport Department is absent without any information. The SPIO, Chief Secretary's Office vide a letter dt. 7-3-2018 has requested to furnish a copy of the Appeal petition dt. 24-7-2017 for furnishing action taken report. A copy of the same be sent.

The Petitioner Sri Dulal Bora stated that he has not received any information on his RTI petition filed on 9-8-2016 and no action was taken on his Appeal petition dt. 24-7-2017.

On perusal of records it appears that a complaint petition was filed by the Petitioner on 26-3-2016 before the Chief Secretary to the Govt. of Assam. The RTI petition filed on 16-8-2016 before the SPIO, office of the Chief Secretary to the Govt. of Assam was transferred to the SPIO of Transport Deptt. vide Chief Secretary's letter dt. 16<sup>th</sup> August, 2016, since the subject matter of the RTI petition relates to TGransport Deptt. The SPIO of the Chief Secretary's office did not enclose the original complaint petition dt. 26-3-2016 which is the basis of the RTI petition dt. 16-8-2016.

In view of the above a copy of the complaint petition dt. 26-3-2016 be sent to the SPIO, Transport Deptt. On receipt of the complaint petition the SPIO, Transport Deptt. is directed to inform the petitioner within 30 days from the date of receipt of this order:-

- a) whether any enquiry has been ordered or any action has been taken on the Petitioner's original complaint petition dated 9-8-2016 and if so, file No. from which the inquiry had been ordered, the name of the Inquiry Officer and the present designation,
- b) copy of the inquiry report if any.

The name of the person complained against has been mentioned in the complaint petition itself and as such is found to be redundant.

With the above order the 2<sup>nd</sup> Appeal petition dt. 24-7-2017 is disposed of.
