O R D E R 19-03-2018

The Petitioner Md. Imran Hussain is present. He stated that he had not received the notice for hearing today, but he was informed over telephone by the Issue Asstt. He stated that he collected a copy of the notice today. The Public Authority to be represented by the SPIO Office of the Head Teacher, Lakhminath Bezbaruah High School, Narua, Nalbari and the 1st Appellate Authority to be represented by the Inspector of School, Nalbari are absent. They may not have received the notices due to postal irregularities.

The Petitioner submitted that no information had been received from the Public Authority on RTI petition filed on 24-8-2017 and after filing his 1st Appeal petition before the Inspector of Schools Nalbari.
